Safety and Supervision:

I acknowledge that while Greenhills Summer Camp will make every reasonable effort to ensure the safety of all camp participants, I understand that there may be inherent risks associated with certain camp activities. I agree to inform my child about the importance of following camp rules and safety guidelines to minimise these risks.

Liability Waiver:

I release Greenhills Summer Camp, its owners, directors, officers, employees, and volunteers from any and all liability for injuries, damages, or losses arising from or related to my child's participation in the summer camp activities, except in cases of proven gross negligence or willful misconduct. We hereby inform all parents/guardians that accidents may occur during team sports or individual games at the Summer Camp. Greenhills Summer Camp cannot be held liable for any injuries or accidents resulting from these activities

Emergency Medical Treatment:

In the event of an injury or medical emergency during the camp, I authorise Greenhills Summer Camp and its staff to seek emergency medical treatment for my child as deemed necessary. I understand that every effort will be made to contact me or the emergency contact provided before any medical intervention.

Personal Belongings:

I understand that Greenhills Summer Camp cannot be held responsible for any loss or damage to personal belongings brought by my child to the camp. It is my child's responsibility to keep their belongings safe and secure.

Changes and Cancellations:

I acknowledge that Greenhills Summer Camp reserves the right to modify or cancel camp activities, schedules, or the entire camp in the event of unforeseen circumstances

or reasons beyond their control. In such cases, I understand that I may be entitled to a refund based on the camp's cancellation policy.

Dismissal from Camp:

I understand that Greenhills Summer Camp reserves the right to dismiss any camper from the program if their behaviour is deemed unsafe, disruptive, or in violation of camp policies. In such cases, no refunds will be provided.

Communication

Communication for Greenhills Camp will primarily be conducted via WhatsApp, and parents/guardians are advised that approximately 99% of camp-related communication will be facilitated through this platform. Additionally, Greenhills Camp will share group information, including children's names, parents' names, and any relevant medical/educational issues with the camp teachers for the purpose of ensuring the safety and well-being of all camp participants.
